



# GW Joint Elections Commission 2024 Elections Complaint Form

This form must be used to file complaints for alleged elections rules violations during the 2024 Student Body Elections. Complaints must meet all the standards outlined below to be properly filed. Both pages of this complaint form must be filed together. There is a signature requirement on both pages.

## Jurisdiction:

- The alleged complaint(s) must be a direct, explicit violation(s) of the Joint Elections Commission Bylaws or adopted rules. Complainant(s) are required to specify the bylaw or rule(s) that a candidate allegedly violated.
- The JEC does not have jurisdiction over any complaints that fall outside of its Charter (SGA Bylaws 700). Any filed complaint that includes a violation not covered in the JEC Charter may be dismissed.
- Complaints that fall outside of the jurisdiction of the JEC may include, but are not limited to violations of: The George Washington University Student Code of Conduct, any applicable rules and regulations of the George Washington University, and/or any local, state, or federal laws.

## Confidentiality:


- Confidentiality is an integral element in the violations process. Alleged complaints will be published online if probable cause is established, but all names, except for the accused candidate and the complainant(s), will be redacted. Personal information such as phone numbers, addresses, and emails will also be redacted before publication.

## Filing Requirements:

- To file a complaint, the complainant(s) must properly complete this submission form and email it to both the JEC and Chief Investigator email addresses. o JEC Email: [jec@gwu.edu](mailto:jec@gwu.edu)
- Complaints must be filed within three calendar days of observing such a violation, unless incapacitated or unable.
- All complaints must include these elements:
- A specific reference to the Rule of the Commission Charter violated.

- An explanation of the alleged incident or violation including the time, place, location, and at least one witness (the witness may be the complainant). o Any evidence pertaining to the matter.

I understand the parameters of a JEC complaint and the filing requirements.

Description of the Incident or Violation (Must allege facts that plausibly suggest liability.)

Description: Upon entering the SGA office, four pages (Exhibits 1-4) were discovered on the front desk. These pages, titled "Dan Saleem for GW Student Government Association President 2024 Official Endorsement Form," all featured the logo "Dan Saleem, 2024." Below the logo was a space designated for the name of the endorsing organization, followed by the statement

"hereby endorses Dan Saleem for the 2024-2025 GW SGA Presidential Election." Spaces were also provided for organization representatives to add their printed names and signatures.

Section 70611: (a) The discovery of these exhibits in the SGA Office at 4:09 PM indicates a violation of the Unlawful Distribution of Campaign Material, as this occurred before the official campaign start date of April 1st. (b) The absence of the JEC logo on the exhibits (1-4) further demonstrates that these materials were not authorized by the JEC as official campaign material. (c) The location of these materials at the SGA office front desk contravenes the restricted zone policy. The SGA Office is located on the 4th floor of the USC, thereby violating the rule that campaigning is only permitted on the 1st floor of the USC.

Section 70613: (b) The presence of exhibits 1-4 in the student advocacy center suggests that unauthorized activities took place in this space, thereby constituting an unlawful use of resources and spaces.

Section 70621: (a) The presence of these pages in the SGA office demonstrates conduct related to the unlawful distribution of campaign material before the official campaigning date, distribution of unregistered campaign material, violation of restricted zones, and campaigning in the student advocacy center. It is evident that this candidate has not adhered to the rules and regulations established by the JEC.

Section 70622: (a) Moreover, the fact that some exhibits appear to be completed while others are not (for example, Exhibit 1 has been signed off by the GW Desis, and Exhibit 4 has been completed by the ESports organization, whereas Exhibit 2, labeled as the GW Red Cross, and Exhibit 3, labeled by the GW Sailing Team, are not fully completed) indicates an attempt at violation. The candidate appears to seek completion of these documents, which would further breach sections related to the unlawful distribution of campaign material before the official campaign date, distribution of unregistered campaign material, violation of restricted zones, and campaigning in the student advocacy center.
